St. Brigid Family Event Season Pass

The role of the HSA is to assist the school administration, faculty, and staff in building a community of faith. Our bylaws guide us to be a vehicle of communication between the school and home while reinforcing the values of a Christian education. We work together with the school and members of the community to stimulate interest in activities pertaining to the school and its students, offering both educationally and socially enriching activities for students, families, faculty and staff.

The HSA events require financial support, and it is our responsibility to find creative ways to meet the financial needs as determined by the Pastor and/or Principal for the events. We are reaching out to our school families before the start of school in hopes to alleviate the financial gaps we face each year to host our HSA community building events through a Family Event Season Pass for \$100 per family.

Last year, the HSA spent approximately \$20,000 hosting the following events:

- New Family BBQ
- Halloween Trunk or Treat
- Grandparents Day
- Santa's Workshop
- Valentine Candy Grams
- Catholic Schools Week
- Mother / Son Event
- Father / Daughter Dance
- Teacher Appreciation Week; including catered breakfast and lunch
- Field Day

Our goal this year is to be fiscally responsible and plan for each event with a set budget. To do this, we are seeking support through the purchase of a St. Brigid Family Event Season Pass. Last fiscal year, the HSA raised \$18,428 with expenses of \$14,267 with total revenue of \$4,160. A **one-time \$100 contribution per family** will provide you **pre-purchased access** to the following HSA events and bridge the gap in our budgeting:

- 10/21/2023 Halloween Party & Trunk or Treat - \$25 per family
- 2/10/2024 Mother Son Event - \$30 per family
- 3/22/2024 Multicultural Event - \$25 per family
- 4/5/2024 Father Daughter Dance - \$30 per family
- 6/3/2024 Field Day
 - T-shirts are the largest expense - it would eliminate seeking business sponsorships for the shirts.

The pass will also financially support the following HSA events:

- 8/28/23 Welcome Back Ice Cream Social
- 10/21/2023 Halloween Trunk or Treat
- 11/22/2023 Grandparents Day
- 12/4 - 12/8 Santa's Workshop (supports merchandise ONLY)
 - Will NOT cover student gift purchases.
 - 2022/2023 = Santa's Workshop was a loss of \$1,172
- 2/14 Valentine Candy Grams
- 1/29 - 2/2 Catholic Schools Week
- 2/10/2024 Mother / Son Event
- 4/5/2024 Father / Daughter Dance
- 3/22/2024 Multicultural Event
- 5/6 - 5/10 Teacher Appreciation Week **This does not include individual class gifts.
- 6/3 Field Day

The following St. Brigid Activities are NOT covered by the Season Pass because they are NOT HSA events:

- After School Enrichment Programs
- Club Fees
- St Brigid Athletic Team Participation
- Middle School Dances

Purchase of the Family Event Season Pass will be due by 9/6 (Back to School Night)

- A one-time \$100 contribution per family will occur through Fast Direct and will eliminate the constant "asking" that occurs during the school year.
 - To be paid via fast direct or check dropped off with Mrs. Bull at the front office.
 - Donations above \$100 are welcomed - this would help cover a family who is unable to pay the \$100 HSA Family Season Pass
